23 June 2020 – Mapletree North Asia Commercial Trust Management Ltd., as manager (the “**Manager**”) of Mapletree North Asia Commercial Trust (“**MNACT**”), wishes to announce that 4,264,513 new units in MNACT (“**Units**”) will be issued at an issue price of S\$0.8752 per unit pursuant to MNACT’s distribution reinvestment plan (“**DRP**”) in respect of MNACT’s distribution for the period from 28 February 2020 to 31 March 2020 (the “**Distribution**”) on 24 June 2020.

The new Units will be credited by 24 June 2020 to securities accounts of MNACT unitholders (“**Unitholders**”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 24 June 2020.

The new Units will rank pari passu in all respects with the existing units.

Following the issuance of the new Units pursuant to MNACT’s DRP for the Distribution, the total number of units in issue will increase from 3,362,627,432 to 3,366,891,945.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited will receive their respective entitlements to the Distribution in cash on 24 June 2020.
