ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 2H FY20/21 DISTRIBUTION

Further to the announcement dated 22 April 2021 by Mapletree North Asia Commercial Trust Management Ltd., as manager (the “**Manager**”) of Mapletree North Asia Commercial Trust (“**MNACT**”), in relation to the application of the distribution reinvestment plan (“**DRP**”) to MNACT’s distribution for the period from 1 October 2020 to 31 March 2021 (the “**2H FY20/21 Distribution**”), the Manager wishes to announce that the issue price of the new units in MNACT (“**Units**”) to be issued under the DRP is S\$1.0449 per Unit.

The issue price represents a 1.5% discount¹ to the adjusted volume-weighted average traded price (“**Adjusted VWAP**”) per Unit for all trades on the SGX-ST for each of the Market Days during the period of 10 Market Days prior to and ending on the Record Date of 30 April 2021.

The notice of election is expected to be despatched to all Eligible Unitholders² on or around 7 May 2021. The Manager will announce further details about the despatch of the DRP documents in due course.

² “**Eligible Unitholders**” means persons registered as unitholders of MNACT in the register of Unitholders or, as the case may be, the Depository Register, as at 5.00 p.m. on the Record Date on 30 April 2021 and with Singapore registered addresses. “**Depository Register**” shall have the meaning ascribed to it in the Securities and Futures Act, Chapter 289 of Singapore.
